I hope this letter finds you well. I am writing to express my strong opposition to the reopening of the Johnson Street shelter, particularly its current location in close proximity to public schools and parks.

As a concerned resident, parent, grandparent, and fellow small business owner in the neighborhood, I feel compelled to share my firsthand experiences and emphasize the urgent need for reconsideration.

We must take immediate action to relocate the shelter to a more suitable location that prioritizes the well-being of our children.

Furthermore, when the shelter was active and in use this last winter/late spring, the noise disturbances originating from the shelter were unbearable, disrupting the peace and tranquility of our neighborhood throughout all hours the night and early morning.

The constant noise, coupled with the increased foot traffic, contributes to an overall sense of unease and discomfort among residents. This situation not only affects our quality of life but also raises concerns about the safety of our community.

Additionally, the high frequency of police, fire, and EMS calls to the shelter further highlights the strain on our limited resources. It is imperative that we reconsider the current North Avenue/Johnson Street location to alleviate the burden on our emergency services and ensure the safety and well-being of all residents.

As a fellow small business owner in this neighborhood, I have experienced first-hand the unfortunate consequences of the shelter's proximity.

Vandalism and property damage have become all too common, creating an environment of insecurity for both myself and my colleagues and business owners. The current location of

the shelter attracts undesirable activities, which directly impacts the safety of our businesses and employees.

Relocating the shelter away from schools and parks, and further away from the heart of the city, would not only address these concerns but also provide safer schools, public parks and neighborhoods.
