Hi ,

My name is Pamela Shore and I live at 920 Evans Ave, Missoula MT 59801. I write to urge the Council to continue to deny permission for the commercial or private development of any land or buildings on Fort Missoula land.

It is a fallacy that those of us opposing the current plan on appeal before the Council want to see the old buildings at the Fort continue to fail. That is a self serving assertion made by for profit only outsiders. People who seek to abscond with historic community assets. They wish to turn our patrimony into profit for their own pocket.

If private residences are built, access to the area will be denied to the public. Over the years I have picnicked in the very area to be lost. I have also walked the area with family and in solitude. This is a spectacular asset that should be preserved for all of us now and in the future.

Perhaps a different purchaser would look towards community interests. Perhaps the land there is not appropriate for private development. Perhaps this purchaser should sell his interests to another party who will do a creative community minded project in keeping with the unique history with the property.

This purchaser is not entitled to do whatever he wants. All of us are under constraints. He has not shown willingness to honor the public history of the Fort. Please continue in denying this permit.
