IT SHALL BE THE DUTY OF THE PERSON DOING THE WORK AUTHORIZED BY A PERMIT TO ASSURE THAT ALL REQUIRED INSPECTIONS ARE SCHEDULED 24 HOURS IN ADVANCE AND APPROVED BY THE CITY INSPECTORS. FURTHERMORE, IT SHALL BE THE DUTY OF THE PERSON REQUESTING THE INSPECTION TO PROVIDE ACCESS TO AND MEANS FOR INSPECTION OF THE WORK. A HOMEOWNER MAY SECURE A PERMIT FOR AND MAY WIRE ONLY HIS OWN BUILDINGS USED ONLY FOR HIS OWN USE. BUILDINGS USED AS RENTALS, BUSINESSES, ETC. AND ALL CONTRACT WORK MUST BE WIRED BY A LICENSED ELECTRICAL CONTRACTOR USING ONLY LICENSED ELECTRICIANS. THE INDIVIDUAL WHO SIGNS THIS APPLICATION ASSUMES ALL RESPONSIBILITY AND LIABILITY FOR THE WORK PERFORMED AS SPECIFIED HEREIN.
