Summary Description and rationale of project and funding sources:

Reroof and insulate Missoula City Shops, housing Fleet Services, Communications, and Sign shops. The City shop's steel roof has degraded and now requires replacement due to rust through and low areas that pool water. City Facilities Services responds multiple times per year to locate and repair leaks causing pooling of water in the shops and office areas. The thinning of the roof surface due to rust has become a safety hazard to staff who need to make repairs or service HVAC equipment on the roof. This is also a risk for slips and falls in the shop from pooling water. This CIP will provide for the overlay of the existing roof with ridged insulation and decking, allowing for the application of a roof membrane. This will provide @ a 25 year warranty, add energy efficiency and work toward city energy goals.

History & Current Status: Impact if Cancelled or Delayed

This roof is original to the building, prior to the acquisition by the City, and is well past its useful lifespan. Roof replacement was originally included in the ongoing City Performance Contract project for \$900,000. We believe we can complete this project outside of that project at a lower cost. The condition of the roof continues to worsen and the possibility for property damage or injury to staff that have to access rooftop HVAC units is a serious concern. Costs have been increasing dramatically in the last years; we do not envision the cost for this project decreasing.
