Summary Description and rationale of project and funding sources:

The multi-use asphalt courts at Playfair Park and Fort Missoula have long exceeded their useful lifespan. Continuing repair efforts at Playfair are no longer a good investment. The size, extent and number of cracks is increasing rapidly. The tennis courts at Fort Missoula Park did get a resurfacing in 2017 but the identified underlying structural integrity issues of these courts was not addressed. Parks Recommends replacing the asphalt courts at Fort Misosula Regional Park and Playfair park at the same time. A recent estimate to demolish and replace the courts at both locations came in at ~\$4M. Parks recommends a partnership between the City of Missoula, Missoula County Public School District, the County of Missoula, and local tennis groups be convened to secure funding for these projects. For clarity, the funding description below indicates the Playfair courts to be funded in FY22 and the FMRP Courts to be funded in FY23.

History & Current Status: Impact if Cancelled or Delayed

Currently, 4 of 12 courts at Playfair are deemed unsafe for play and unrepairable. It is expected, if this request is not funded, additional courts may need to be closed in CY 2022 at Playfair. The Courts at FMRP have identified structural integrity issues. The FMRP courts were resurfaced in 2017 but the structural issues were not addressed.

Are there any site requirements/ Potentially Affected Interest (PAI) Coordination:

Local Tennis Association, Missoula County Public Schools Tennis programs, and City P&R Tennis programs, and the general parklit are effected by loss of courts related to closures.
