Summary Description and rationale of project and funding sources:

The recently acquired South Hills Spur (SHS) or Barmeyer property, is located in the Farviews Pattee Canyon Neighborhood and will eventually connect the south side of Missoula to Mt. Dean Stone open space. Impact fees were approved to develop appropriate trailheads, related trail signage, rehabilitate an old developer road, and to remove electrical service boxes on the property. FY23 funding is to improve the parking lot of the Barmeyer trailhead primarily through redesign and paving.

History & Current Status: Impact if Cancelled or Delayed

In 2020, the road rehab project was completed by students from Missoula College's Heavy Equipment Program. We are waiting on a final access easement with adjacent property owners to determine scope and exact costs for removal of electrical boxes. We are also waiting on Missoula County to provide final design standards to finish construction of the main SHS trailhead. In 2020, the City acquired an additional 360 of Mt. Dean Stone. in FY23 we hope to expend remaining funds to pave the Barmeyer Trailhead and remove remaining electrical boxes on the property.
