Summary Description and rationale of project and funding sources:

Playfair park is a 63 acre park located in central Missoula and serves a significant surrounding neighborhood population including Russell School - which has a high low-moderate income service population . The current design dates back to the mid 1900's, and the park is in need of significant upgrades to keep up with an ever increasing desire for multi-use sports fields and service to all area residents. Project partners will work with a Landscape Architecture firm to develop a new master plan for the park that meets the current and future needs of Missoula. Impact Fees have currently been approved in the amount of \$150K. FY22 funds will be used to begin the master planning process. One of the higher priority improvements related to the master plan is expected to be the replacement of the deteriorating playground located between Splash MT and the tennis courts. The estimated expense to replace the playground is in FY23. Improvements to the playground include infrastructure, toys, poured in place fall zone, ADA access, and site restoration. Playfair is the City's largest park without a functional or complete playground.

History & Current Status: Impact if Cancelled or Delayed

Playfair Park is in need of a new and inclusive playground, updated sports facilities to better utilize the park, plus passive use areas to meet growing demands and population.
